**ORDER**

As per the Govt. order1st cited, sanction was accorded for the appointment of Dr.I.Muhammed Muhusin Koya, Sr. Veterinary Surgeon, Veterinary Hospital Ambalappuzha as District Mission Co-ordinator, District Mission Office, Alappuzha. Accordingly he was on deputation as District Mission Officer ,Alappuzha with effect from 2-11-2012 to 2-11-2013.

In the Govt. order read as 2<sup>nd</sup> paper above,his deputation period was extended for a further period of 1 year from 17-9-14 and also regularised the period of deputation from 2-11-2013 to 27-5-2014 as extended period of deputation as he had no objection certificate from the parent dept. As per the proceedings of the Director ,Kudumbasree read as 3<sup>rd</sup> paper above, he was reverted to the parent department on 31-5-2016. The Executive Director, Kudumbashree, Thiruvananthapuram in his letter read as 4<sup>th</sup> paper above has reported certain administrative problems occurred which has caused the overstay on deputation.

3. The Executive Director, Kudumbashree vide his letter as 5<sup>th</sup> read above had forwarded a proposal for the regularisation of period of overstay of deputation of Dr.I.Muhammed Muhusin Koya, Sr.Veterinary Surgeon as District Mission Co-ordinator, Alappuzha. from 17/09/2015 to30/05/2016 .

Government have examined the matter in detail and are pleased to accord sanction to regularise the period of overstay of Dr.I.Muhammed Muhusin Koya, Sr. Veterinary Surgeon, Veterinary Hospital Ambalappuzha as former District Mission Co-ordinator, District Mission Office, Alappuzha for the period from 17.09.2015 to 31.05.2016 as extended period of deputation.
