ORDER

Sri. Arun. R.T, S/o the late Radhakrishna Pillai. S, who died in harness on 25.01.2016 while working as Assistant Engineer, LSGD Section, Ettumanoor Municipality, has applied for employment assistance under the Compassionate Employment Scheme as per the application read as 2nd paper above. The application was submitted within the prescribed time limit. The deceased Government servant had put in a total service of 27 years 7 Months and 3 days.

- 2. The applicant is 23 years old as his date of birth is 17.01.1994. He has passed SSLC, Plus Two and B.Tech in Civil Engineering. The request is for appointment in the post of Overseer Gr I/Grade II/Grade III in LSGD Engg Wing in Kollam District and he is qualified for that post.
- 3. The Chief Engineer, LSGD, Thiruvananthapuram and the District Collector, Kollam as per the letters read as 3rd and 4th papers above respectively have recommended the request of Sri. Arun. R.T. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. None of the dependants of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant has got appointment under the Scheme.

- 4. The District Collector, Kollam as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs 5,72,760/- (Rupees Five lakh seventy two thousand seven hundred and sixty only). Sri. Arun. R.T is eligible for employment assistance under the compassionate employment scheme as Overseer Grade III.
- 5. Government have examined the matter in detail and are pleased to accord sanction for the appointment of Sri. Arun. R.T., S/o the late Radhakrishna Pillai. S, Prakash Bhavan, Kadappa, Near Udaya Jn. Mynagappally, Kollam, as Overseer Grade III in the Local Self Government (Engineering Wing) Dept, preferably in Kollam District in the existing or next arising vacancy under the Compassionate Employment Scheme subject to the conditions laid down in Government Order read as 1st paper above. Necessary entries in this regard will be made in the Service Book of the deceased Government servant and also in the Establishment Register of the office where the deceased employee last worked and the entries will be attested by the Head of Office/Head of Department.
- 6. The employment assistance ordered under the scheme will be cancelled if and when Government find that there was any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding the application or during the course of inquiry conducted by the Department in which he is appointed.
- 7. The Chief Engineer, Local Self Government Department, Thiruvananthapuram will issue necessary posting orders to Sri. Arun. R.T, after verification of the original documents produced by him to prove age, educational qualification, medical fitness and after confirming the genuineness of the same and also subject to other conditions under the scheme in force.
