**ORDER**

As per the G.O. read as 1<sup>st</sup> paper above Shri. Sreekumar.B was appointed as Director (Alternate Thinking) in Partner Kerala Mission and he joined duty as Director on 3/4/2017. The 15<sup>th</sup> Executive Committee of the Partner Kerala Mission held on 18/05/2017, have decided the mode of appointment of Shri. Sreekumar.B as on contract basis for a period of three years with a consolidated salary of Rs. 60,000/- per month with 5% Annual increase. The Executive Committee has also decided to obtain approval of Government for fixing the salary and its annual increase.

2. As per the letter read as 2<sup>nd</sup> paper above Chief Executive Officer, Partner Kerala Mission has requested Government to issue orders on fixing the terms and conditions for the appointment of Shri. Sreekumar.B, Director (Alternate Thinking), Partner Kerala Mission as proposed by the Executive Committee, indicating eligibility conditions on other matters viz. Travelling Allowance, Leave etc.

3. Government have examined the matter in detail and are pleased to fix the the terms and conditions of the appointment of Shri. B. Sreekumar as Director (Alternate Thinking) in Partner Kerala Mission as follows, subject to the condition that, Government will not provide any additional fund for the

purpose and expenditure in this regard will be met by Partner Kerala Mission itself. Since the appointment is on contract basis he will not be eligible for TA

Mode of Appointment - Contract basis

Period of Appointment - 3 years from the date of Joining .

Remuneration - Rs.60,000/-(Sixty Thousand only) per month

Leave - Admissible as per Appendix VIII, PartI, KSR.
