**ORDER**

As per the sanction order read as 2<sup>nd</sup> paper above, Government of India sanctioned the grant-in aid amount of Rs.4,00,00,000/-(Rupees Four Crore only) to the State as 1<sup>st</sup> instalment of Central Share for implementation of National Rural Livelihoods Project(NRLP)/Aajeevika for the year 2017-18. As per the letter read as 3<sup>rd</sup> paper above, the Executive Director, Kudumbashree has submitted a proposal for releasing the Central Share of an amount of Rs.4,00,00,000/-(Rupees Four Crore only). An amount of Rs.4,00,00,000/- is re-appropriated for EAP Component of NRLM (National Rural Livelihoods Mission) vide Government Order read 4<sup>th</sup> paper above.

In the circumstances, Government are pleased to accord administrative sanction and to authorise the Commissioner for Rural Development to release an amount of Rs.4,00,00,000/- (Rupees Four Crore only) to the Executive Director, Kudumbashree, Kerala being the 1<sup>st</sup> instalment of Central Share for implementation of National Rural Livelihoods Project/Aajeevika during 2017-18 from the current year budget provision as detailed below.
