ORDER

As per the order read as 2nd paper above the Hon'ble Kerala Administrative Tribunal has directed the Government to take a decision on Annexure A4 representation of the applicant after affording him an opportunity of being heard within two months from the date of receipt of a copy of the order or at any rate, before all three specified vacancies in Sasthamcotta or Panmana Grama Panchayat are filled up, which ever is earlier.

As per the order of the Hon'ble Tribunal, Sri. Maryson Michael. Assistant Secretary. Yeroor Grama Panchayat was heard on 17.8.2017. During the hearing he stated that he is a native of Kollam district and had been working as Assistant Secretary in Pattancherry Grama Panchayat in Palakkad district from 23.1.2014 onwards. From 01.09.2015 he has been posted at Kadampanadu Grama Panchayat in Pathanamthitta District. He said that for General Transfer 2017 he had given options in Panmana. Sasthamkotta and Chavara Grama Panchayats, all in Kollam district. But he was transferred to Yeroor Grama Panchayat. He stated that he is entitled to get a transfer to one of the opted stations taking into consideration his total length of outstation service i.e. from 23.1.2014. As there are two vacancies in the Sasthamkotta and one in Panmana Grama Panchayats he has requested to grant him transfer in any of the above Panchayat.

Government have examined the matter in detail. As per letter read as 3rd above the Director Of Panchayat has reported that there are vacant posts in Sasthamkotta. Panmana and Nilamel Grama Panchayats in Kollam District. Since there are vacant posts in

Sasthamkotta and Panmana Grama Panchayats and the applicant is eligible as perseniority the Director of Panchayats is directed to give him transfer in any one of the two Panchayats.

The order of the Hon'ble Kerala Administrative Tribunal read above is thus complied with.
