ORDER

The Executive Director, Kudumbashree vide letter read as 2nd above has forwarded the proposal for the regularisation of overstay of deputation of Sri.Rajesh N., Senior Grade Assistant, General Administration Department, Government Secretariat as Assistant District Mission Co-ordinator, District Mission Office, Kannur From 01.05.2016 to 27.01.2017.

2. The Government have examined the matter in detail. The Officer on deputation will be relieved of his duties on the date of expiry of the sanctioned period unless the competent authority has, with requisite approval, extended the period of deputation, in writing, prior to the date of its expiry. In the event of the officer overstaying, he will be liable to disciplinary action and the period of overstay will not be counted for the purpose of pension and that any increment due during the period of overstay will be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre and the officer will be precluded from drawing pay and allowances from the date on which the sanctioned term of foreign service expires and when the officer on deputation is promoted to a higher post in his parent department, he will be reverted to his parent department, unless specific orders retaining the officer on deputation even after his promotion are issued by Government on the specific request of the borrowing Department. Even though based on the report of the Executive Director, Kudumbashree, Thiruvananthapuram in the letter read as 2nd paper above, Government are pleased to accord sanction to regularise the period of overstay of Sri.Rajesh N., Senior Grade Assistant, General Administration Department, Government Secretariat as former Assistant District Mission Co-ordinator, District Mission Office, Kannur for the period from 01.05.2016 to 27.01.2017 as extended period of deputation.
