**ORDER**

The work under PMGSY 2004-05 (Phase IV) Package No.KR 02-06 of Mulamthuruthi Block in Ernakulam District was awarded to the contractor Shri Wilson Poulouse. Due to the non payment to the contractor certain disputes arose between the Contractor and the Department. The contractor filed WP(C) No.3342/17 before the Hon'ble High Court. As per the judgement read above, the Hon'ble Court directed the respondents to take on board Ext P9 and arrive at a final conclusion with in two months from the date of receipt of copy of the judgement after providing an opportunity of being heard to the petitioner or any other interested or affected persons. Meanwhile, based on the request of the petitioner, the Chief Engineer as per the letter read above, has recommended to constitute the Standing Empowered Committee as specified in clause 24.3 of the agreement to settle the dispute as per the direction of the Hon. High Court.

2. In the circumstances, Government are pleased to constitute the Standing Empowered Committee for the purpose of settling the disputes, invoking the provisions under clause 24.3 of SBD for PMGSY with the following composition.

- I Secretary, LSGD - Chairman
- II. Chief Engineer, Local Self Government Department -Official Member
- III. Shri.R.Murukesan, Chief Engineer(Rtd.) - Non-official Member

3. The Chief Engineer, KSRRDA is directed to take necessary steps to present the case before the Standing Empowered Committee for redressal of grievances.
