**ORDER**

In compliance with the order of the Hon'ble Kerala Administrative Tribunal dated 30.09.2016 read as 1<sup>st</sup> paper above, the advice number of Sri.Muhammed Ja, in the Block Development Officer's rank list published by Kerala Public Service Commission on 15.04.2002, was reassigned and was placed above to Sri.P.Abdul Azeez (Sl.No.15) and below to Sri.G.Anil (Sl.No.14). Subsequently, the Commissioner for Rural Development has revised the final seniority list of Block Development Officers appointed from 27.01.1997 to 31.12.2002 and Sri.Muhammed Ja was placed as 965 (A) and allowed all benefits eligible to him as per order read as 2<sup>nd</sup> paper above. On rectification of seniority in the final seniority list of Block Development Officers, the select lists prepared for promotion to the posts of Assistant Development Commissioner, Deputy Development Commissioner and Joint Development Commissioner are to be revised for consequential benefits.

6. In the select list for promotion to the post of Joint Development Commissioner, notified vide GO(P) No.24/2017/LSGD dated 27.04.2017, the name of Sri. Muhammad Ja is placed as Sl. No.5 (A) in between Sri.G. Anil (Sl.No.5) in the select list and Sri.P.Abdul Azeez (Sl No.6).
