## ORDER

As per the Interim Order read as 2<sup>nd</sup> paper above, the Hon'ble Kerala Administrative Tribunal have directed the I<sup>st</sup> Respondent, the Government to take a decision on the request of Smt. Geetha. G, Overseer Grade III for a posting in Ummannoor or Mylom in Kollam District after affording an opportunity of being heard to the applicant within 4 weeks from the date of interim order.

- 2. The petitioner was transferred from Vettikavala Block Panchayath to Pulinkunnu/Kavalam Grama Panchayath as per the proceedings of the Chief Engineer read as 1<sup>st</sup> paper above. The Hon'ble Tribunal as per the interim order dtd 05.07.2017 has stayed the implementation of Annexure A1 order and the stay is still in force.
- 3. In pursuant to the Hon' KAT direction, the applicant was heard by the Under Secretary, LSGD on 05.10.2017.
- 4. The applicant has contended that she was posted at Vettikkavala Grama Panchayath, Kollam on 8.9.2016 and was transferred to Pulinkkunnu, Kavalam Grama Panchayath, Alappuzha District, which is her 4<sup>th</sup> transfer in two years. On her transfer to Vettikkavala, in order to look after her family consisting of her son studying in 5<sup>th</sup> standard and aged ailing mother, she took a rented building nearby and admitted her son in a local school. If the present transfer is implemented, the education of her son would be badly affected. It is pointed out that there is vacancy in Ummannoor Grama Panchayath and Mylam, Vettikkavala Grama Panchayath so as to accommodate the incumbent. It is reported that Smt. G. Geetha has been transferred to Mylam Grama Panchayat by the Chief Engineer LSGD as per proceedings read as 3<sup>rd</sup> paper above in compliance with the directions of the Hon,ble Tribunal to the convenience of the applicant.

5. Government have examined the matter in detail and it is found that the grievances of the petitioner has been resolved following her transfer and posting in Mylam Grama Panchayath on her request. Accordingly, the order of the Hon'ble KAT in OA no.1272/2017 read as 2<sup>nd</sup> paper above, is complied with.
