ORDER

Government of India have sanctioned an amount of Rs.21,60,00,000/- (Rupees Twenty One Crore Sixty Lakh only) to the State as Central Assistance for the 4 clusters namely Punnayurkulam&Vadakkakkad, Edappal&Vattamkulam, Kanjikuzhy&Mararikulam, Chembilode&Peralassery of Phase II Syama Prasad Mukherji Rurban Mission (SPMRM) as per the sanction order read as 2nd paper above. As per the letter read as 3rd paper above, the Commissioner, Rural Development has requested to release and transfer credit a total amount of Rs.36,00,00,000/- (Rupees Thirty Six Crore Only) being Central and State Share towards 1st instalment of CGF for the SPMRM Phase II through additional authorization. Accordingly, Government have authorised an additional expenditure to the tune of Rs. 36,00,00,000/- (Rupees Thirty Six Crore Only) under the Head of Account 2515 -00- 102 - 35 SPMRM (Plan-voted), as per the Govt. Order read as 4th paper above, to accommodate the Central Assistance and the corresponding State Share towards the Scheme SPMRM for the year 2017-18.

2. In the above circumstances, Government are pleased to release a total amount of Rs. Rs.36,00,00,000/- (Rupees Thirty Six Crore Only) as 1st instalment of Central and State Share of Critical Gap Fund for Syama Prasad Mukherji Rurban Mission (SPMRM) clusters under Phase II for the year 2017-18 under the Head of Account 2515-00-102-35 SPMRM (Plan-voted) to the Special Treasury Savings Bank Account maintained for Syama Prasad Mukherji Rurban Mission (SPMRM) subject to the condition that the Commissioner for Rural Development/SPMRM should draw the amount from the Special Treasury Savings Bank Account as and when it is required.
