### ORDER

Sri. N.C.R. Unnikrishnan, Retired Principal and Deputy Development Commissioner, Extension Training Centre, Mannuthy filed OA(Ekm) No.241/2016 before the Hon'ble Kerala Administrative Tribunal praying for a direction to the respondents to reckon the service rendered in University of Kerala from 30.08.1972 to 31.03.1981 as qualifying service for pensionary benefits and refixation and disbursement of arrears accordingly. The Hon'ble Kerala Administrative Tribunal as per order read above directed the respondents to count his past service in University of Kerala from 30.08.1972 to 31.03.1981 as qualifying service alongwith the service under the Government for computing pensionary benefits and to refix his monthly pension and pensionary benefits within two months from the date of receipt of the copy of the order and disburse all consequential benefits including arrears to the applicant within a further period of two months thereafter.

2) Government have examined the matter in detail and are pleased to direct the Commissioner for Rural Development to revise the monthly pension and pensionary benefits in respect of the applicant by counting his past service in the University of Kerala, from 30.08.1972 to 31.03.1981, as qualifying service alongwith the service under the Government and disburse the arrears of pensionary benefits, consequent to the revision, to the applicant forthwith. This shall not be quoted as precedent in the future cases.

3) The directions contained in the order of the Hon'ble Kerala Administrative Tribunal read above is thus complied with.
