ORDER

As per the Order read as 2nd paper above, the Hon'ble Kerala Administrative Tribunal have directed the first respondent, Government , to consider and pass orders on Annexure A4 representation submitted by the petitioner Smt. Beena. A, Asst. Executive Engineer, after affording her an opportunity of being heard. It is also directed that the applicant is free to point out any station of her convenience of being posted and such requests shall also be considered. It has also been ordered that until orders are passed on Annexure A4 by the 1st respondent, the interim order will continue to be in force.

2. The petitioner was transferred from Vettikkavala Block Panchayat to Pandalam Block Panchayath as per the GO read as 1st paper above.

3. Pursuant to the Hon' KAT direction, the applicant was heard by the Additional Secretary, LSGD on 12.01.2017.

4. Smt.Beena A submitted that she had been working in Vettikkavala Block Panchayat w.e.f. 23.05.2014 followed by the transfer from Thallikulam Block Panchayat, Thrissur. She had not completed 3 years of service at Vettikkavala. She contended that she cannot be away from Kollam district as she is the only person to look after her father, who is a diabetic patient and she has two daughters studying in Kollam district and her husband is working in Palakkad. So she requested that she may now be allowed to continue at Vettikkavala BP. She also requested that, since the post of Asst. Executive Engineer at Mukhathala BP in Kollam district will be open by May 2017, due to the superannuation of the present officer, she may be considered for the said upcoming vacancy at Mukhathala.

5. In this regard, the CE, LSGD as per the letter read as 3rd paper above, has reported that the petitioner may be allowed to continue in Vettikkavala Block Panchayath as nobody has been appointed there.

6. Government have examined the matter in detail and pleased to order that Smt.Beena . A, Asst. Executive Engineer is allowed to continue in Vettikavala Block Panchayath, Kollam.

7. The Government Order read above is amended to this extent.

8. The order of the Hon'ble KAT in OA No.512/2016 read as 2nd paper above, is complied with accordingly.
