V.T.Balram M.L.A representing Thrithala Constituency.

- 2. Government have examined the matter in detail and are pleased to accord administrative sanction for the work "Construction of Chalisseri Panchayath Auditorium(Ambedkar Hall) Chalisseri Panchayath" through Habitat Technology Group\_at an estimated cost of Rs. 30 lakh (Thirty Lakh only)) under the LAC-ADS of Sri Adv. V.T.Balram M.L.A representing Thrithala Constituency with special sanction to take up the work for execution following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1<sup>st</sup> paper above and subsequent Government orders, subject to the following conditions,
  - I) Since there are no bidding process for selection of contractor (M/s Habitat) and they are executing works directly, no contractors profit need be given. However, Over Head charges and applicable Centage charges are allowable.
  - II) TS for this work has to be accorded by the LSGD Engineering Wing in compliance of relevant Government Orders issued by Administrative Department & Finance Department.
