E.T. Taison Master, MLA representing Kaipamangalam Legislative Assembly Constituency.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work, Panchayat Ground Gallery construction in Sreenarayanapuram Grama Panchayath at Thrissur District as deposit work at an estimated cost of Rs. 53 lakhs (Rupees Fifty Three Lakhs only) under the LAC-ADS (2016-17)of Sri. 4) The genuineness of the rates and provisions shall be verified and confirmed by the TS authority.


The expenditure in this regard will be debited under the head of account '4515-00-800-96-projects under LAC- ADS (NP)'.
