ORDER

As per the representation read as 1st paper above, Shri.D. Saju, Secretary, Mavelikkara Municipality has requested to fix his seniority in between Shri.T.S.Saifudeen and Shri.M.C.John in view of G.O. (Rt) No.433/2017/LSGD dated 15.02.2017 and to take appropriate steps to include him in the Select List for promotion to the post of Corporation Secretary/Additional Corporation Secretary.

2. In the connection with the above, Shri.D. Saju, Secretary, Mavelikkara Municipality filed O.A. No.433/2017 before the Hon'ble Kerala Administrative Tribunal. The Hon'ble Tribunal as per the Order read as 2nd paper above, disposed the OA with a direction to the 2nd respondent (Convenor, DPC(Higher)) to cause the disposal of Annexure MA4 representation (appeal submitted by him) by convening a review DPC as expeditiously as possible, at any rate, within a period of two months from the date of receipt of a certified copy of the order.

3. The Adhoc Departmental Promotion Committee met on 27.09.2017 decided to assign the seniority (for promotion to the cadre of Municipal Secretary Grade II) of Shri. D. Saju just above Shri. M.C.John by

revising the Select List for the year 2011 published vide G.O.(P) No.313/2011/LSGD dated 15.12.2011 and to fix his seniority (for promotion to the cadre of Corporation Secretary/Additional Corporation Secretary)in between Shri.T.S.Saifudeen and Shri.V.J.Kurian by revising the Select List for the year 2017 published vide G.O.(P) No.20/2017/LSGD dated 30.03.2017. The Committee also decided to grant notional promotion to the applicant in the cadre of Municipal Secretary Grade II, I and Corporation Secretary/Additional Corporation Secretary with effect from the date of promotion of his immediate junior.

4. The Select Lists for the years 2011 and 2017 have been revised vide G.O.(P) No.91/2017/LSGD dated 23.11.2017 and G.O.(P) No.89/2017/LSGD dated 23.11.2017. Consequential promotion will be given in due course.

5. The order of the Hon'ble Kerala Administrative Tribunal read as 2nd paper above is thus complied with.
