### ORDER

As per the representation read as 1<sup>st</sup> paper above, Shri. Saifudeen T.S., Secretary, Perumbavoor Municipality has requested to finalise the disciplinary action initiated against him as per Memo of Charges No.LSGD-EU1/105/2016-LSGD dated 27.04.2016 and to grant him promotion to the post of Corporation Secretary/Additional Corporation Secretary.

2. In the connection with the above, Shri. Saifudeen T.S., Secretary, Perumbavoor Municipality filed O.A. No.433/2017 before the Hon'ble Kerala Administrative Tribunal. The Hon'ble Tribunal as per the Order read as 2<sup>nd</sup> paper above, disposed of the original application with a direction to the 3<sup>rd</sup> respondent [Convenor, DPC (Higher)] to dispose Annexure A10 representation produced along with MA No. 2412/2017 by convening a review DPC (Higher) as expeditiously as possible, at any rate, within two months from the date of receipt of a certified copy of the Order.

3. The disciplinary action initiated against Shri.t.S.Saifudeen has been finalised as per G.O.(Rt) No.2267/2017/LSGD dated 05.07.2017. The Adhoc Departmental Promotion Committee met on 27.09.2017 decided

to assign the seniority of Shri.T.S.Saifudeen in between Shri.Binu Francis and Shri.D.Saju by revising the Select List for the year 2017 published vide G.O. (P) No.20/2017/LSGD dated 30.03.2017. The Committee also decided to grant notional promotion to the applicant in the cadre of Corporation Secretary/ Additional Corporation Secretary with effect from the date of promotion of his immediate junior.

3. The Select Lists for the year 2017 has been revised vide G.O.(P) No.89/2017/LSGD dated 23.11.2017. Consequential promotion will be given in due course.

4. The order of the Hon'ble Kerala Administrative Tribunal read as 2<sup>nd</sup> paper above is thus complied with.
