ORDER

As per the representation read as 1st paper above, Shri.S.Jayakumar, Secretary, Thirurangadi Municipality has requested to take appropriate action to include him in the Select List for promotion to the post of Municipal Secretary Grade I.

2. In the connection with the above, Shri.S.Jayakumar, Secretary, Thirurangadi Municipality filed O.A.(E) No.861/2017 before the Hon'ble Kerala Administrative Tribunal. The Hon'ble Tribunal as per the Order read as 2nd paper above, disposed of the OA by directing the 2nd respondent (Convenor, DPC (Higher)) to consider and pass appropriate orders on Annexure A7 appeal within a period of three months from the date of receipt of a copy of the order after affording an opportunity of personal hearing to the applicant.

3. The applicant was heard by the Additional Secretary on 16/08/2017. In the hearing, the applicant submitted that he has entered in Service as Municipal Secretary Grade III on September 2000. He has not been considered for promotion for the reason that disciplinary action is pending

against him. Hence, he has requested to finalise the disciplinary action pending against him and to grant him promotion to the post of Municipal Secretary Grade I.

4. Government have examined the matter in detail. The Ad hoc Departmental Promotion Committee (Higher) met on 27/09/2017 assessed the merit and ability of officers to be included in the Select of Municipal Secretary Grade I for the year 2017. The DPC omitted the name of Shri.S.Jayakumar on the ground that disciplinary action for major penalty is pending against him as per Memo of Charges No.3911/EU1/2007/LSGD dated 27.04.2011 and 30677/EU1/2013/LSGD dated 06.09.2013. Government are taking steps to finalise the disciplinary action against the applicant, observing procedural formalities.

5. Hence, the order of the Hon'ble Kerala Administrative Tribunal read as 2nd paper above is thus complied with.
