ORDER

The Secretary, Kerala Public Service Commission as per the letter read as 1<sup>st</sup> paper above has advised Shri.JacobVarghese, Vandakathil, Maramon, Pathanamthitta-689549 for appointment to the post of Lecturer Grade I ,Animal Husbandry(by transfer) in the Scale of Pay of Rs.20,740-36,140 (pre- revised).

2. As per the letters read as 2<sup>nd</sup> paper above Commissioner for Rural Development has reported a vacancy in the post of Lecturer Grade I Animal Husbandry(by transfer) in the KILA-Centre for Organic farming and Waste Management(formerly known as Extension Training Centre,Thaliparamba ) at Thaliparamba.

3.In the above circumstances, Government are pleased to appoint Shri.Jacob Varghese,Vandakathil,Maramon,Pathanamthitta as Lecturer Grade I Animal Husbandry(by transfer) in the KILA-Centre for Organic farming and Waste Management(formerly Extension Training Centre,Thaliparamba ) at Thaliparamba in the existing vacancy (by transfer) in the scale of pay of Rs. Rs.20,740-36,140 (Pre revised) on provisional basis under Rule 9 (a) (i) of the General Rules KS &SSRs, 1958 as provided for in Rule 10 (b) of those rules .

The advice of the candidate is subject to the Rule 3 (c) of the General Rules of the KS &SSRs 1958.

4.The Candidate is directed to report for duty before the Principal of the KILA-Centre for Organic Farming and Waste Management, Thaliparamba, Kannur ( Formerly Extension Training Centre,Thaliparamba ) within 15 days from the date of receipt of the appointment order, failing which the appointment order will be cancelled and the Kerala Public Service Commission will be advised to cancel the advice without any further notice. The Candidate should bring with him the original documents to prove age, educational qualifications and original One Time Verification Certificate failing which he will not be admitted to duty. He should also produce Medical Certificate (as prescribed in Rule 13, Part I, Kerala Service Rules) and G.O (P) No.20/2011/P&ARD dated 30.06.2011 carrying thumb impression and passport size photo signed by a Medical Officer not below the rank of a **Civil Surgeon** , three passport size photographs (duly attested on the reverse side) by a Gazetted Officer of State Government Service and AADHAR Card (UID Card) as stipulated in Circular No. 12521/AVC VI (3)/13/P&ARD dated 26.07.2013, so as to verify the identity. If they are not in possession of the AADHAR Card, Voter ID Card/ PAN CARD should be produced. They should produce necessary relieving orders, failing which they will not be admitted to duty.

5.The candidate should produce Community / Non Creamy Layer Certificate in original for verification when they report for duty, if applicable.

6.The candidate is also informed that in the event of discharge from service for want of vacancies, they may either re-register their name in the office of the Kerala Public Service Commission and get re-appointed on further advice from the Kerala Public Service Commission in which case they shall lost the right of probation to the post in the department from which they were discharged for want of vacancies or may wait for their turn for re-appointment to the post in the department in case they desire to continue as probationer in the post from which they were discharged.

7.The date of joining duty of the candidate should be reported to the Kerala Public Service Commission and to the Government immediately after the candidate joining duty. In case, the candidate does not join duty within the joining time allowed in the appointment order, the fact should be reported to the Kerala Public Service Commission as well as the Government immediately.
