ORDER

Crime Case No.2212/16 has been registered against
Shri.Reghuraman, former Secretary, Guruvayur Municipality, as per
Section 376 (1) of Indian Penal Code 1860 and he has been arrested
on 19.12.2016 and was on judicial custody vide RP No.3324. Hence
Shri.Reghuraman has been suspended from service as per the
Government Order read as 1st paper above.

2. The Hon'ble High Court, as per the order read as 2nd
paper above, has allowed the Crl M.C. and quashed the proceedings in
Crime No.2212 of 2016 of Guruvayur Police Station. Hence,
Shri.Reghuraman has been reposted at Palakkad Municipality, as per
the Government Order read as 2nd paper above. The officer joined
duty on 11.05.2017 FN.

3. The Director of Urban Affairs, as per the letters read as
4th paper above, has recommended to treat the suspension period in
respect of Shri.Reghuraman as duty for all purposes as per Rule 56 B
(4) of Part I KSRs.

4. Government have examined the matter in detail and are pleased to regularise the period of suspension from 20.12.2016 to 07.05.2017 as duty for all purposes including pay and allowances, less subsistence allowance already drawn and the intervening period from 08.05.2017 to 10.05.2017 is regularized as joining time and/or leave due as admissible to the officer as per Note 2 below Rule 56 B (9) Part I KSRs.
