As per the letter read as 2nd paper read above, Government of India have sanctioned an amount of Rs.3,06,82,871/- (Rupees Three Crore Six Lakh Eighty Two Thousand Eight Hundred and Seventy One Only) towards the 1st instalment of Central Share in respect of Mahila Kissan Sashaktikaran Pariyojana(MKSP) Annual Action Plan(AAP) for attaining economic empowerment, food, nutritional and livelihood security from Kudumbashree Mission for the year 2014-15. As per the letter read as 3rd above, the Director, Kudumbashree has submitted proposal for releasing the corresponding State share amount of Rs.1,02,27,624/-(Rupees One Crore Two Lakh Twenty Seven Thousand Six Hundred and Twenty Four Only).

In the circumstances, Government are pleased to accord sanction to release an amount of Rs.1,02,27,624/-(Rupees One Crore Two Lakh Twenty Seven Thousand Six Hundred and Twenty Four Only) as corresponding state share of the 1st instalment of Attappady Mahila Kissan Sashaktikaran Pariyojana under NRLM for the year 2014-15 and also to authorize the Commissioner for Rural Development to transfer credit the above amount from the Head of Account 2501-06-197-48(04) NRLM-General to the Executive Director, Kudumbashree.
