**O R D E R**

As per letter read as 1<sup>st</sup> paper above an amount of Rs. 418.37 Lakh has been sanctioned by Government of India as part of 1<sup>st</sup> instalment to the State as Central assistance towards conducting Social Audit in the State & Staffing of Independent Social Audit Unit under MGNREGA, for the financial year 2017-18. The Director, Mahatma Gandhi NREGA Social Audit Society Kerala as per letter read as 2<sup>nd</sup> paper above has requested to release the amount urgently so as to start effective functioning of the Social Audit Society. As per the Government order read as 3<sup>rd</sup> paper above, authorisation for additional expenditure to the tune of Rs. 4,18,37,000/- only have been sanctioned under the Head of Account 2505-02-101-97-34.

In the Circumstances, Government are pleased to accord sanction to release an amount of Rs. 4,18,37,000/- (Rupees Four Crore Eighteen Lakh and Thirty Seven Thousand only) being the 1<sup>st</sup> instalment of Central Assistance received towards conducting Social Audit in the State and staffing of Independent Social Audit Unit under MGNREGA, by debiting the expenditure under the head of account '2505-02-101-97-34 Other Charges (Plan Voted). The Commissioner for Rural Development is authorised to transfer credit the amount to Account No. 37364716754 of Director, MGNREGA Social Audit Society Kerala maintained with SBI Nanthencode Branch.

3. The Commissioner for Rural Development shall submit proposal to regularise the expenditure through re-appropriation of savings only within the grant before the close of the current (2017-18) financial year.
