**ORDER**

For the smooth functioning of Partner Kerala Mission, the Director has appointed two persons viz. . Smt.Padma.P and Smt. Jisha Mary A. in the Mission on daily wage basis w.e.f. 10.7.2017 as Clerk-cum-Typist and Office Attendant respectively. Based on the GO read as 1<sup>st</sup> paper above , they were paid wages at the rate of Rs.710/-per day to Clerk cum Typist and Rs.685/- per day to Office Attendant against the actual days they worked. Total payment made to them since 10.7.2017 is as follows:-

Clerk cum Typist- Rs.85200/- for 120 days.  
Office Attendant- Rs 86995 - for 127 days.

2. As per GO read as 2<sup>nd</sup> paper above, Government have decided to terminate the functioning of Partner Kerala Mission and consequently the service of Clerk-cum-Typist and Office Attendant has been ceased w.e.f 31.12.17. As per the Note read as 3<sup>rd</sup> paper above, the Director, Partner Kerala Mission has requested Government to ratify his action in having appointed Smt.Padma.P and Smt. Jisha Mary A. in the Mission on daily wage basis w.e.f. 10.7.2017 to 31.12.17 as Clerk-cum-Typist and Office Attendant respectively and paid wages as per the approved rate for the actual days worked.

3. Government have examined the matter in detail and are pleased to ratify the action of Director, Partner Kerala Mission in having engaged Smt.Padma.P and Smt. Jisha Mary A. in the Mission on daily wage

basis w.e.f. 10.7.2017 to 31.12.17 as Clerk-cum-Typist and Office Attendant respectively and paid wages as per the approved rate for the actual days they have worked as mentioned above.


