ORDER

Government of India have sanctioned an amount of Rs.903.00lakhs(General), Rs.523.74lakhs(SCP), Rs.379.26lakhs(TSP) during the year 2015-16 towards 2nd instalment of Central share of ongoing project under MKSP for collective farming through women groups in all the Districts of Kerala implemented by the SRLM-Kudumbashree. Government of India have credited the Central share through RTGS to Kudumbashree-Kerala SPEM (SRLM). Executive Director, Kudumbashree requested to release the corresponding State share in the funding pattern 60:40. State share to be released is detailed below.
