ORDER

As per the sanction order read as 2nd paper above, Government of India have sanctioned an amount of Rs.4,00,00.000/-(Rupees Four Crore only) to the State as 2nd instalment of Central Share(EAP) for implementation of National Rural Livelihoods Project(NRLP)/Aajeevika for the year 2017-18. As per the letter read as 3rd paper above, the Executive Director, Kudumbashree has submitted proposal for releasing the Central Share.

- 2. As per the G.O. read as 4th paper above, sanction has been accorded for the reappropriation of a sum of Rs.4,00,00,000/- under the head of account 2501-06-197-48(09). NRLM(FAP-Share) for releasing the aforesaid Central Share towards the EAP Component of NRLM (National Rural Livelihoods Mission).

In the circumstance, sanction is accorded for the release of an amount of Rs.4.00,00,000/- (Rupees Four Crore only) being the 2nd instalment of Central Share for implementation of National Rural Livelihoods Project/Aajeevika during 2017-18 from the current year budget provision as detailed below.
