As per letter read as 1st paper above the Convenor, Capital Region Development Programme has requested to accord sanction for the release of an amount of Rs. 12.48 crores towards clearing of the outstanding amount payable to the Transactional Advisor pending since March 2017, for meeting the expenses of Economic Impact Assessment (EIA)/Social Impact Assessment(SIA) studies of Outer Area Growth Corridor project being done by L&T Infrastructure Engg. Ltd. for the CRDP from the h/a 5475-00-800-92(P) Major Infrastructure Development Projects. As per Government Order read as 3rd paper above, the Planning & Economic Affairs Department has allocated an amount of Rs. 12.48 Crores to CRDP-II from the h/a 5475-00-800-92(P) Major Infrastructure Development Projects to CRDP Phase II. As per Government Order read as 4th paper above Government have accorded Administrative Sanction for an amount of Rs 12.48 crores to the CRDP-II from the h/a 5475-00-800-92(P) Major Infrastructure Development Projects (MIDP) to the head of account 4217-01-800-99- CRDP.

2) In the above circumstances Government are pleased to accord sanction for the release of an amount of Rs 12.48 crore (Twelve crores and Forty Eight Lakhs only) for meeting the expenses related to technical studies of CRDP from the h/a 4217-01-800-99- CRDP- Phase II subject to the condition that the expenditure in this regard will be incurred

only after the connected appropriation Act has been passed by the Legislature and published as extra ordinary Gazette Notification.
