**ORDER**

In compliance with the order of the Hon'ble Kerala Administrative Tribunal dated, 23.08.2016 read as 1<sup>st</sup> paper above, the probation of Sri.C.M.Joseph in the cadre of Block Development Officer has been declared with effect from 13.05.2005. He was also granted senior grade promotion with effect from 13.05.2005 as per proceedings read as 2<sup>nd</sup> paper above. The select list prepared in 2005 for promotion to the post of Assistant Development Commissioner was revised, as per notification read as 4<sup>th</sup> paper above, to include his name in the Select list for promotion to the category of Assistant Development Commissioner notified vide Notification No.1698/EA3/2005/LSGD dated, 16.03.2005 as Serial No.11 (A), in between Sri.Babukumar G. (Sl. No.11) and Sri.Rajasekharan Nair B. (Sl. No.12)

The Commissioner for Rural Development, as per letter read as 5<sup>th</sup> paper above, submitted proposal for notionally promoting Sri.C.M.Joseph, Block Development Officer (Rtd.) as Assistant Development Commissioner with effect from 13-05-2005, the date on which his immediate junior Sri.
