<u>ORDER</u>

As per G.O.(P) No.154/2000/LSGD dt 29/05/2000 Govt had constituted Ombudsman for Local Self Government Institutions w.e.f 29/05/2000 and the following persons were appointed as Ombudsman and they joined their offices on 30/05/2000

- 1. Justice P.A. Mohammed (Judge, High Court of Kerala, Ernakulam)
- 2. Sri.Moidu Ahammed Nissar (District Judge on duty as Law Secretary to Government of Kerala)
- 3. Sri.P.S.Divakaran (District Judge on other duty as Registrar, High Court of Kerala, Ernakulam)
- 4. Dr.D.Babu Paul (Additional Chief Secretary to Government of Kerala)
- 5. Sri.K.Mohanachandran(Chairman, Kerala State Electricity Board, Thiruvananthapuram)
- 6. Prof.T.V.Balan, Priyendu, Chirakkal, Kannur-11
- 7. Prof.R.Balakrishnan Nair, 67, Vrindavan Colony, Pattom Palace.P.O, Thiruvananthapuram.
- 2) According to Section 271G of the Panchayath Raj Act, 1994, a person appointed as Ombudsman shall hold office for a term of five years from the date on which he enters upon his office. But it was amended in 2001 and a new Section 271G(4) was substituted which provided that Ombudsman shall hold office for a term of 3 years from the date on which he enters upon his office. Accordingly, Government dissolved the above then

Ombudsmen w.e.f. 14/09/2001. The period for which they could not complete their tenure was from 15/09/2001 to 29/05/2003.

- 3) The provisions of the said amendment Act 12 of 2001 were challenged by the members of the Ombudsman in the writ petitions read as 1st paper above. The Learned Single Judge held that the petitioners of the writ petitions ie. the members of the Ombudsman are entitled to the relief and compensations as prayed for. It was further held by the Learned Single Judge that being an old matter it is for the State Government to negotiate with the petitioners to have reduction of the compensation amount.
- 4) Government filed Writ Appeals read as 2nd paper above challenging the Judgment read as 1st paper above. While disposing the said writ appeals filed by Government, the Hon'ble High Court, as per the judgment read as 2nd paper above, held as follows:
- i) The Writ Petitioners shall be entitled for salary for the period during which they could not complete their tenure of Ombudsman consequent to statutory intervention however in computing the said salary, the allowances and perks shall not be included.
- ii) During the aforesaid period if any emoluments or pecuniary benefits have been received by the petitioners, the said amount shall be deducted by the State while computing the emoluments to be paid to the petitioners.
- iii) The appellant shall compute the aforesaid amount and make payment of the same within a period of three months to the petitioners.
- 5) Government have examined the matter in detail and are pleased to sanction the emoluments due to the members of the former Ombudsman as per the computation of emoluments in the Annexure.
- 6)The Secretary to the Ombudsman for Local Self Government Institutions is authorised to disburse the benefits flowing out of the judgment dated 27.01.2016 to all the seven members of the dissolved Ombudsman though all are not party to the court case.

The details of Pay in respect of Professor T.V. Balan is as follows:

As the pay of Ombudsman is fixed at the rate of pay of High Court Judge, the existing pay at the time of assumption of charge was Rs.26,000/-. Deducting the Pension drawn by Sri.T.V.Balan (Rs.8,251/-), his pay as Ombudsman was fixed at Rs.17,749/- with effect from 31.05.2000, the date on which he assumed charge.

The entitlement of Sri.T.V.Balan during the period of being kept out of office of Ombudsman is as follows:

From 14.9.2001 to 30.5.2003, he is eligible for Rs.17,749/- per month. While calculating the entitlements, any pecuniary benefits (other than pension and allowances authorized by the AG) received by him from the Department/Government during the aforesaid period may be deducted.
