ORDER

As per the Government Order read as 1st paper above, sanction was accorded for the release of an amount of Rs.140,02,50,000/- (One Hundred and Forty crore and Two Lakh Fifty Thousand Only) from the Head of Account 4515-00-800-98-(01) towards the 2nd installment of Central Share of Programme Fund of PMGSY sanctioned by MoRD, GoI, for the year 2017-18.

2. The Member Secretary, KSRRDA, in his letter read as 2nd paper above has reported that, the total fund released under the Head of Account 4515-00-800-98-(01) is Rs.169.13Cr (i.e. Programme Fund 1st installment-Rs.28.105Cr, Administration Fund 1st installment-Rs.1Cr and Programme Fund 2nd installment-Rs.140.025Cr.). As Rs.19.130Cr was released more than the budget provision of 150 Cr, re-appropriation of Rs.19.130Cr is needed from the Additional State Share under the Head of Account 4515-00-800-98-(03). In the case of State Share under the H/A 4515-00-800-98-(02) a re-appropriation of Rs.12.753Cr. is also needed. As sufficient fund is available under the Head of Account 4515-00-800-98-(03), the Member Secretary, KSRRDA has requested sanction for re-appropriation of funds for releasing the 2nd installment of Central Share of PMGSY Programme Fund for the year 2017-18 of Rs.140,02,50,000/- in full, and the corresponding State Share of Rs.93,35,00,000/- and also sanction to release the fund.

3. As per the G.O read as 3rd paper above, sanction has been accorded for the re-appropriation of a sum of Rs.31.883 Cr under the above Head of Accounts i.e. an amount of Rs.19.130 Crore under the H/A 4515-00-800-98-(01) and Rs.12.753/- Crore under the H/A 4515-00-800-98-(02), from the H/A 4515-00-800-98-(03) for releasing the 2nd installment of Central Share (Rs.140,02,50,000/-) of PMGSY Programme Fund for the year 2017-18 in full and corresponding State Share (Rs.93,35,00,000/-).

4. In the above circumstance, Govt. are pleased to accord sanction for the release of Rs.140.025Crore(One Hundred and Forty crore and Two Lakh Fifty Thousand Only) from the h/a 4515-00-800-98-(01) towards the 2nd installment of Central Share of Programme Fund of PMGSY for the year 2017-18 and Rs. 93.35 Crore as 2nd instalment of State share of Programme Fund from the h/a 4515-00-800-98-(02) including the amount sanctioned through re-appropriation as per the Government Order read as 4th paper above.
