ORDER

Government of India sanctioned the grant-in aid amount of Rs.1,40,000,00/- (Rupees One Crore forty Lakh only) as Central Assistance for the Syama Prasad Mukherji Rurban Mission (SPMRM) clusters (35Lakhs for each cluster) under PhaseIII for the year 2017-18 namely Nedumpana&Thrikovilvattam, Puthukode&Kavassery, Thanalur&Niramaruthur, Kadalundy&Olavanna as per the sanction order read as 2nd paper above. As per the letter read as 3rd paper above, the Commissioner, Rural Development has requested to release the said amount of Rs.1,40,000,00 /- (Rupees One Crore forty Lakh Only) for the preparation of Integrated Cluster Action Plan (ICAP) and for setting up institutional arrangements for the implementation of SPMRM through additional authorization. As per the Government Order read as 4th paper above, additional authorisation to the tune of Rs.1,40,000,00 /-(Rupees One Crore forty Lakh Only) has been made under the Head of Account 2515 -00-102-35 SPMRM (Plan-voted) to accommodate the Central Assistance for the Scheme SPMRM for the year 2017-18.

2. As Government of India has not approved the Kadalundy&Olavanna cluster under phaseIII, sanction is accorded for the release of an amount of Rs.10500000/- (Rupees One Crore Five Lakh Only) towards the Administrative expenses for Phase III Rurban clusters for the scheme SPMRM ie. preparation of Integrated Cluster Action Plan (ICAP) for the 3 clusters(Nedumpana&Thrikovilvattam, Puthukode&Kavassery, Thanalur&Niramaruthur) and for setting up institutional arrangements for the implementation of Syama Prasad Mukherji Rurban Mission (SPMRM) for the year 2017-18 under the Head of Account 2515-00-102-35 SPMRM (Plan-voted), subject to the condition that the fund shall be utilised as per the provisions stipulated in guidelines of Ministry of Rural Development.

3. The Commissioner for Rural Development/SPMRM is authorized to transfer credit the amount to the Special Treasury Savings Bank Account maintained for Syama Prasad Mukherji Rurban Mission (SPMRM) and to draw the amount as and when it is required.
