ORDER

As per the letter read as 2nd paper above Government of India have sanctioned the grant-in aid amount of Rs.51449000/-(Rupees Five Crore, Fourteen Lakh and Forty Nine Thousand Only) to the State towards 3rd installment of Central Share under National Rural Livelihood Mission (NRLM) (General component) during the year 2017-18. In the letter read as 3rd paper above the Executive Director, Kudumbashree has requested to release the Central and State share for implementation of NRLM/Aajeevika for the year 2017-18.

2. After having examined the matter in detail, Government are pleased to accord sanction to release an amount of Rs.5,14,49,000/-(Rupees Five Crore, Fourteen Lakh and Forty Nine Thousand Only) as Central Share from the Head of Account "2501-06-197-48 (06) NRLM - General (60% CSS) - Central share" and its corresponding State Share of Rs.3,42,99,333/-(Rupees Three Crore Forty Two Lakh Ninety Nine Thousand Three Hundred and Thirty Three Only) from the Head of Account "2501-06-197-48 (04) NRLM- General (40% State Share)".

3.The Commissioner, Rural Development Department is authorized to draw and disburse the above amount to the Executive Director, Kudumbashree.

4.This transfer of fund is exempted from all the existing treasury restrictions.
