ORDER

As per the sanction order read as 2nd and 3rd paper above, Government of India have sanctioned a total amount of Rs.9,67,07,000/- (Rupees Nine Crore Sixty Seven Lakh Seven Thousand Only) towards part payment of 1st installment of Central Share to Kudumbashree, State Poverty Eradication Mission, Kerala in respect of Annual Action Plan (AAP) under Start up Village Entrepreneurship Programme (SVEP) for promotion of enterprise based livelihood in the 12 blocks namely Nileshwaram in Kasargod district, Kuthuparamba in Kannur district, Perambra in Kozhikode district, Panamaram in Wayanad district, Nilambur in Malappuram district, Nenmara in Palakkad district, Kodakara in Thrissur district, Vaikom in Kottayam, Idukki in Idukki district, Thykattussery in Alapuzha district, Pathanapuram in Kollam district, Vamanapuram in Thiruvananthapuram identified for the purpose, for conducting baseline and market potential study. Government of India have directly credited the amount to Kudumbashree through RTGS.

The Executive Director, Kudumbashree has requested to accord sanction for releasing the 1st installment of State Share of Rs.64471333/- in proportion to the Central Share of Rs.9,67,07,000/- under the funding pattern 60:40.

- 2.Govt have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.6,44,71,333/-(Rupees Six Crore Forty Four Lakh Seventy One Thousand Three Hundred and Thirty Three Only) being the state share from the Head of Account 2501-06-197-48 (04) corresponding to the central release of Rs.9,67,07,000/-sanctioned towards part payment of 1st installment of Central Share to Kudumbashree, State Poverty Eradication Mission, Kerala in respect of Annual Action Plan (AAP) under Start up Village Entrepreneurship Programme (SVEP) for promotion of enterprise based livelihood in the 12 blocks identified for the purpose, for conducting baseline and market potential study.
- 3. The Commissioner, Rural Development Department is authorized to transfer credit the amount and to disburse the same to Kudumbashree.
- 4. This transfer of fund is exempted from all treasury restrictions.
