ORDER

As per the letter 2nd, 3rd, 4th and 5th paper read above Government of India have sanctioned the grant-in aid amount of Rs.13,81,73,999/-(SCP), Rs.15,84,73,278/-(TSP), Rs.9,70,71,320/-(SCP) and Rs.7,02,93,025/-(TSP) respectively to the State towards implementation of Action Plan under DDU-GKY by Kudumbashree for the Financial Years 2016-19. As per the letter read as 7th above the Executive Director, Kudumbashree has submitted proposal for the release of the Central and its corresponding State share for the purpose.

- 2. After having examined the matter in detail, Government are pleased to accord sanction to release an amount of Rs.39,20,75,531 under the h/a 2225-01-197-48(06) NRLM- SC SP)- 60% CSS and Rs. 38,12,77,172 under the h/a 2225-02-197-48 (06) (NRLM- TSP 60% CSS) including the amount provided through additional authorization vide G.O. read as 6th paper above for effecting the release of central and corresponding state share of SCP & TSP components towards the implementation of Action Plan under DDUGKY for the year 2016-19 .
- 4. The Commissioner, Rural Development Department is authorized to draw and disburse the amount to Executive Director, Kudumbashree.
- 5. The Controlling Officer concerned will take timely steps to regularise this additional expenditure through Reappropriation of Savings only within the Grant before the close of the current financial year.
- 6. This transfer of fund is exempted from all the existing treasury restrictions.
