ORDER

On the basis of the finding in the Quick Verification Report (Q.V
9/16/SCE) that Sri. R. Lalu, Joint Director of Urban Affairs who was on
deputation as Secretary , Greater Cochin Development Authority together
with 3 others have caused a loss of Rs. 7,92,47,000/- to the Great Cochin
Development Authority (GCDA) by selling four pieces of land of GCDA (20 cents in Sy. No. 1002,1013/1, Ernakulam, 20 cents in Sy No. 1044/9, Ernakulam, 20 cents in Sy. No. 497/2 Ernakulam and 45.83 cents in Sy No. 330/12, Elamkulam) , the Vigilance & Anti-Corruption Bureau registered a Vigilance Case No. V.C 15/2016/SCE under Section 13 (1) (d) r/w 13 (2) of Prevention of Corruption Act, 1988 and Section 120 B IPC. Based on the recommendation of the Director, Vigilance & Anti-Corruption Bureau as per the letter read as 1st paper above, Shri.R.Lalu has been suspended from service as per the Government Order read as 2nd paper above.

2. On the basis of allegations, disciplinary action has been

initiated against the accused and Memo of Charges and Statement of Allegations for major penalty has been served on him as per the letter read as 3rd paper above.

3. The Suspension Review Committee held on 21.02.2018 has recommended to reinstate Shri.R.Lalu at a distant place from the place of allegation.

4. Government have examined the matter in detail and are pleased to reinstate Shri.R.Lalu, Joint Director in service revoking the suspension and post him as Joint Secretary, State Election Commission, in the existing vacancy ,pending disciplinary action.
