ORDER

As per Government Orders read as 1st and 3rd paper above, administrative sanction was accorded for an amount of Rs. 21.50 crore (Rupees Twenty one crore fifty lakhs only) and as 8.50 crore (Rupees Eight Crore and Fifty lakhs only) as Grant-in-Aid to KILA for the year 2017 – 18 under the Head of Account '2515-00-003-99-36-Grant-in-aid-General-Non Salary (P).'

As per Government Order read as 3rd paper above sanction was accorded for the release of an amount of Rs. 5 crore (Rupees Five crore only), as 1st installment .

The Director, KILA, as per the letter read as 4th paper above, has requested to release the balance amount of Rs. 2312.26 lakh (Two thousand three hundred twelve lakh and twenty six thousand only) for the timely implementation of the activities of KILA.

Government have examined the matter in detail and are pleased to release an amount of Rs. 2312.26 lakh (Two thousand three hundred twelve lakh and twenty six thousand only) under the Head of Account '2515-00-003-99-36- Grant-in-aid-General-Non Salary (P) ' with permission to transfer credit the amount to the TSB Account of KILA and subject to the condition that the amount should be utilised for the purpose for which administrative sanction was accorded.


The Director of Panchayats will draw and disburse the amount.
