## **ORDER**

As per Government Order read as 1<sup>st</sup> paper above administrative sanction was accorded for an amount of Rs. 1500 lakhs to Information Kerala Mission, under the Head of Account '2515-00-800-86-99 (P)' for the scheme Computerisation of three tier Panchayats during the current financial year subject to certain conditions.

As per Government Order read as 2<sup>nd</sup> paper above sanction was accorded for the release of an amount of Rs. 505.61 lakhs to Information Kerala Mission, under the Head of Account '2515-00-800-86-99 (P)', for the scheme Computerisation of three tier Panchayats during the current financial year.

The Executive Director, Information Kerala Mission as per letter read as 3<sup>rd</sup> paper above has reported that an amount of Rs. 794.32/- lakhs (Rupees Seven Hundred Ninety Four Lakhs and Forty Two thousand only) has already been spent up to 31.01.2018 and has requested to release the remaining sum of Rs. 994.39 under the head of account 2515-00-800-86-99 (Plan).

Government have examined the matter in detail and are pleased to release an amount of Rs. 3,89,51,250/- (Rupees Three Crores Eighty Nine Lakhs and Fifty one thousand Two hundred and fifty only) from the Head of Account '2515-00-800-86-99 (P)' for the computerisation of three tier panchayats subject to the conditions specified in the Government Order read as first paper above and also subject to the following conditions.

- a) The amount shall be utilised for the purpose for which Administrative Sanction has been accorded;
  - b) Utilisation Certificate shall be furnished for the amount released
