As per G.O. read as 1st paper above, Administrative Sanction was accorded for the plan schemes under Suchitwa Keralam (Rural) under the Head of Account 2515-00-101-68 for an amount of Rs.51.67 Crore for the year 2017-2018. As per the G.O. read as 2nd paper above, Rs.12.91 Crore, the 1/4th of the allocation for the Year 2017-18 was sanctioned under Suchitwa Keralam (Rural).

- 2.As projects are not being received from Grama Panchayats under the component "Solid Waste Processing Plant & its Modification" under the Head of Account 2515-00-101-68, the Executive Director, Suchitwa Mission as per the letter read as 3rd paper above has requested to re-allocate Rs 400 Lakh from the total outlay of Rs.500 lakh earmarked for this component for the year 2017-18 to "Source Level Treatment of Waste", as more projects for assistance under the said component are being received in Suchitwa Mission.
- 3. Government have examined the matter in detail and are pleased to re-allocate an amount of Rs. 400 lakh from the component 'Solid Waste Processing Plant and its Modification' to the component 'Source Level Treatment of Waste' so that the total outlay under the component "Source Level Treatment of Waste" is Rs. 510 Lakh (Rs. 110 lakh already earmarked + 400 lakh reallocated from the component "Solid Waste Processing Plant & its Modification") and the total outlay for the component "Solid Waste Processing

Plant and its Modification" is Rs. 100 Lakh (Rs.500 Lakh already earmarked - Rs. 400 lakh re-allocated to the component of "Source Level Treatment of Waste")
