ORDER

The Government vide GO read as (1) and (4) above had approved the Mulavukkad road widening project which envisaged widening of the 5.5 km long road from Mulavukkad to Goshree road to a width of 7m. Administrative sanction for taking possession of land for widening, shifting of the utility lines, construction of road and to get service from KITCO Ltd. have also been accorded vide GO read as (2), (3) and (4) above.

2. The Secretary, Goshree Islands Development Authority vide his letter read above informed that as per the decision of review meeting of the project on 26.07.2016, funds were transferred to KSEB, KWA and BSNL for shifting of utilities of 2nd phase for about 1.5km (upto Thandassery Temple) where most of the land required for road widening has already been taken into possession and submitted the estimate for rectification works of Mulavukkad Road Phase-II prepared by KITCO Ltd with total estimate amount of road work Rs.2,23,72,631/- in which componentwise expenditure is as follows ;

GIDA requested the administrative sanction of above said estimate prepared by KITCO Ltd and sanction to meet the expenditure of work from balance fund available under this project.

3. In the above circumstances, Government are pleased to accord Administrative Sanction to the Mulavukad road widening project Phase II for an amount of

Rs.2,10,99,384/- (Two Crore Ten Lakh Ninety Nine Thousand Three Hundred and Eighty Four Rupees Only) against the original proposal of Rs.2,23,72,631/-subject to the following conditions.

- i. The availability of land, width of roadway and chainages, stability of the pavement shall be ensured by the TS authority.
- ii. The necessity provisions of drain, retaining wall shall be ensured by the TS authority based on relevant circulars of PWD/CTE considering structural stability.
- iii. The reinforcement in the current proposal shall be based on structural requirement considering economy.
- iv. The quantities, rates and provisions shall be verified and confirmed by the TS authority.
- v. The TS authority shall ensure that the estimate is in current DSR with applicable cost index.
- vi. Departmental materials if any shall be properly reused and balance material shall be auctioned as per rules.
- vii. The necessity of drain shall be executed based on the actual requirement at site.
- viii. The stability of Retaining wall and culvert shall be ensured by the TS authority.
- ix. Pedestrian safety shall be ensured in the subject work.
