LSGD - Appointment of Financial Controller in KSRRDA and Constitution of a Selection Committee for the purpose of interviewing the applicants - Sanctioned - Orders Issued.

ORDER

Para (7) of PMGSY guidelines specifies that, "the agency (KSRRDA) shall appoint a Financial Controller to oversee the operationalisation of the rural roads accounting system. The Agency shall maintain centralized accounts, which will be accessed by the Program Implementing Unit (PIU) and the Financial Controller's primary responsibility would be the enforcement of accounting standards and arranging the auditing thereof. The Financial controller would need to be a professional with adequate knowledge and experience of Accounting works".

2. Accordingly as per the letter read above, the Empowered Officer, KSRRDA has informed that the Ministry of Rural Development, Government of India has insisted to appoint a Financial Controller in KSRRDA as mandatory and it is one of the pre-requisites for release of Central Assistance. He has therefore requested sanction for appointing a Financial Controller in KSRRDA on contract basis with a remuneration of Rs.45000/- (Forty Five Thousand) per month inclusive of all allowances with the following qualifications.

- i. MBA (Finance) or an advanced degree on Accounting & Finance with 3 years experience
- ii. Chartered Accounts or Equivalent Degree with 3 years experience (Online accounting experience is preferable)
- iii)Age between 20 to 40 years as on 1/1/2018

3.The Empowered Officer, KSRRDA has also requested to constitute a Committee for the purpose of interviewing the applicants.

4. Government have examined the matter in detail and are pleased to accord sanction for the appointment of a Financial Controller in KSRRDA as per para (7) of PMGSY guidelines, on contract basis for a period of 2 years, observing a transparent process of selection of contract appointment with a remuneration of Rs.45,000/-(Rupees Forty Five Thousand only) per month inclusive of all allowances. The qualification for the post of Financial Controller is detailed below.

- i. MBA (Finance) or an advanced degree on Accounting & Finance with 3 years experience
- ii. Chartered Accounts or Equivalent Degree with 3 years experience (Online accounting experience is preferable)
- iii)Age between 20 to 40 years as on 1/1/2018

5. A Selection Committee is also constituted for the purpose of interviewing the applicants, with the following composition.
