- 3. No other allowances mentioned in G.O.(P) No. 7/2016/Fin dated 20.01.2016 will be made applicable without specific prior orders from the Government and further orders issued in continuation of G.O.(P) No.7/2016/Fin dated 20.01.2016 shall be applicable to the employees of the KILA only with the prior concurrence of Government.
- 4. In case of any doubt regarding fixation of pay, anomalies etc prior consent of Government should be obtained before arriving at a decision.
- 5. Under no circumstances step up of pay will be allowed.
- 6. As regards Employers contributions towards EPF, the conditions in EPF Act and the orders issued by Government from time to time should be strictly followed. The employers contribution towards EPF will be 12% of 15000 (Basic pay + DA).
- 7. No appointments (permanent/ deputation/temporary/ daily waged/ provisional) shall be made in the posts created without the approval of Government and no new post will be created without prior approval of Government by way of Government orders.
- 8. No ratio based promotions, upgradation or redesignation shall be done without formal approval of Government.
- 9. The entire expenditure on the revision of pay and allowances will be met from KILA's internal resources specifically meant for meeting salary expenditure and Government will not provide any financial assistance on account of this. Arrear payments will be based on the financial position of KILA.

- 10. Under no circumstances Government grants of any kind will be diverted for meeting establishment expenditure including salary expenditure and the expenditure of Government grants will be noted against the items itself in accounts.
- 11. Director, KILA will be held personally liable for any kind of discrepancies while implementing the order.


