ORDER

Sri. Asharaf Khan. A, Asst. Exe.Engineer has filed OA(EKM)no.2644/2017 before the Hon'ble Kerala Administrative Tribunal aggrieved by non inclusion of his name in the select list for promotion to the post of Asst.Exe.Engineer by the DPC(H) 2017 which held on 24.10.2017, due to the prevalence of disciplinary action for minor penalty as per the Vigilance recommendation in connection with the irregularities in issuing building permit in Erumely Grama Panchayath.

2. The Hon'ble Kerala Administrative Tribunal, vide order read as 1st paper above, have disposed of OA(EKM)no.2644/2017 directing the Convenor, DPC(H) to consider and pass appropriate orders on Annexure A17 representation, read as 2nd paper above, within a period of 6 weeks from the date of receipt of a copy of the order. It has also been directed therein to consider the eligibility of the applicant on the basis of Note (i) to Rule 28(b)(i) of KS&SSRs while issuing orders on Annexure A17.

3. The request of the applicant in the Annexure A17 representation is to reconsider the above decision of the DPC and to include him in the modified select list 2017 for promotion to the post of Asst. Executive Engineer.

4. The review DPC(H) which convened on 27.02.2018 in pursuant to the above orders of the Hon' KAT has observed that the applicant is eligible for promotion to the cadre of Asst.Exe.Engineer as he was exonerated from charges in the disciplinary action for minor penalty prevailed against him in connection with the Vigilance surprise inspection in Erumely Grama Panchayath, vide GO(Rt)No.449/2018/LSGD dated 15.02.2018. Therefore the DPC(H) has decided to include him as Sl. No. 46(b) just below Smt. Bicini.S whose Sl. No. will be 46 (a) and Rank No. 206 in the modified select list 2017 (*direct quota*) for promotion to the post of Asst.Exe.Engineer. Subsequently, the modified select list 2017 has been approved and published vide GO read as 3rd paper above.

5. In the above circumstances, as the applicant has been included in the modified select list 2017 for promotion to the post of Asst.Exe.Engineer after considering his review petition, the order of the Hon'ble KAT in OA(EKM)no.2644/2017 read as 1st paper above is complied with accordingly.
