<u>ORDER</u>

As per the Government Order read as 1st paper above, sanction was accorded to set up an independent Social Audit Unit in the State for conducting Social Audit under MGNREGA in accordance with the provisions in the Mahatma Gandhi NREGA Audit of Schemes Rules 2011. A full-time Director was appointed in the Social Audit Unit in due course and to assist him, a Social Development Specialist and Social Audit Expert were also appointed. The guidelines issued along with the Government Order read above envisage to appoint District Social Audit Resource Persons(DRPs) for every Rs.30Crore expenditure incurred in 2014-15, at District level, and a Block Resource Person(BRPs) for every three Grama panchayaths. As per para 10.1.6 of the Master Circular 2018-19 of MGNREGS, the selection of the District Social Audit Resource Persons should be done by a Selection Committee with the following structure.

- 1. Chief Secretary or her/his nominee, Chairperson
- 2. Principal Secretary of the Department implementing MGNREGA (Me

- 3. Director, Social Audit Unit (Member-Convenor)
- 4. Representative of the Ministry of Rural Development, GoI not below the rank of Director/Deputy Secretary(Member)
- 5. Representative of a Civil Society Organization having experience of working for the rights and entitlements of rural people(Member)
- 2. The Director, MGNREGA Social Audit Society, Kerala as per the Note read as 2 nd paper above has informed that the 4th Governing Body meeting of the MGNREGA Social Audit Society held on 23.01.2018 resolved to entrust the Director, SAU to initiate action on the selection of District Resource Persons and Block Level Resource Persons.
