## <u>ORDER</u>

Sri. Ummer. K, Asst. Exe. Engineer has filed OA(EKM)no.2189/2017 before the Hon'ble Kerala Administrative Tribunal aggrieved by the non inclusion of his name in the select list for promotion to the post of Asst. Exe. Engineer by the DPC(H) 2017 which held on 24.10.2017, due to the prevalence of disciplinary action for minor penalty as per Vigilance recommendation in connection with the irregularities in the construction of compound wall for Government Hospital, Areacode.

- 2. The Hon'ble Kerala Administrative Tribunal, vide order read as 1<sup>st</sup> paper above, have disposed of OA(EKM)no.2189/2017 directing the Convenor, the DPC(H) to consider and pass appropriate orders on Annexure A7 representation, read as 2<sup>nd</sup> paper above, by convening a meeting of the DPC(H) as expeditiously as possible at any rate within two months from the date of receipt of a certified copy of the order.
- 3. The request of the applicant in the Annexure A7 representation is to reconsider the decision of the DPC(H) held on 24.10.2017 and to include him in the select list 2017 for promotion to the post of Assistant Executive Engineer.
- 4. The review DPC(H) which convened on 27.02.2018 in pursuant to the above orders of the Hon' KAT has observed that the disciplinary action pending against the applicant has been finalised by barring one annual increment without cumulative effect for three months as per GO(Rt)No.20/2018/LSGD dated 03.01.2018. Since the disciplinary action has been finalised on 2018, the Committee has observed that he become eligible for promotion as Asst.Exe.Engineer in the year 2018 only. Therefore, the Committee has decided to include him in the select list 2018 (diploma quota) as Sl. No.'1(a)' just below Smt. P.K. Sindhu whose Rank No. is 190 and Sl. No. 1. Subsequently, the modified select list 2018 has been approved as per the recommendation of the DPC(H) and published as per Government Order read as 3<sup>rd</sup> paper above.

5. In the above circumstances as the applicant has been included in the modified select list 2018 for promotion to the post of Asst.Exe.Engineer after considering his review petition, the order of the Hon'ble KAT in OA(EKM)no.2189/2017 read as I<sup>st</sup> paper above is complied with accordingly.
