ORDER

As per the Order read as 2nd paper above, the Hon'ble Kerala Administrative Tribunal have disposed of OA 1875/2017 filed by Smt. Reena. O.T., Asst.Engine. directing the Ist respondent, i.e Govt to consider Annexure A6 representation read as a paper above, in accordance with the transfer norms and pass appropriate orders validate two months from the date of receipt of a copy of the order.

- The applicant has filed the above OA aggrieved by her transfer from Chirayinkeezhu GP, Thiruvananthapuram to Chennithala/Thripperumthara Grams Panchayath as per proceedings no.E3-2100/08/CE/LSGD dtd 27.09.2017 of the Child Engineer, LSGD. In the Annexure A6 representation, the applicant has contented the she joined duty in Chirayinkeezhu GP less than 2 year ago and therefore has requested to retain her in the said station. As per the interim order of the KAT dtd 03.10.2017, the applicant was allowed to continue in Chirayinkeezhu GP till the orders are passed or Annexure A6 representation.
- 3. The Chief Engineer, LSGD, vide letter read as 3rd paper above has reported that the applicant was transferred to Chennithala-Thripperumthara GP, Alappuzha based of administrative convenience in pursuant to the resolution of the Chirayinkeezhu levying charges of dereliction of duties against her with a plea to transfer her out. He applicant who had already completed 5 years of service in Thiruvananthapuram distinction has no legitimacy to continue service in the District as many Asst. Engineers including female employees are striving for a transfer to the District. Now, an Asst. Engineer has been posted to the Chennithala-Thripperumthara GP for completing the annual plan the Department smoothly. However, the applicant has requested for a transfer to Thrissur or Ernakulam Districts in the General Transfer 2018. Therefore, it has been reported to allow her to continue in Chirayinkeezhu GP for the time being for project implementation process of the Financial year 2017-18 to complete.

- 4. In the above circumstances, the Chief Engineer is hereby directed to consider the request of the applicant in the General Transfer 2018 as per transfer norms and until then she shall be allowed to continue in Chirayinkeezhu GP.
- 5. The order of the Hon'ble KAT in OA 1875/2017 read as 2nd paper above, is complied with accordingly.
