ORDER

Sri. K.C. Subramanian, Asst. Exe.Engineer has filed OA(EKM) No.2527/2017 before the Hon'ble Kerala Administrative Tribunal aggrieved by his supersession in the select list for promotion to the post of Exe.Engineer by the DPC(H) 2017 which held on 24.10.2017; due to the prevalence of disciplinary action for minor penalty as per Vigilance recommendation against him in two cases.

2. The Hon'ble Kerala Administrative Tribunal, as per order read as 1<sup>st</sup> paper above, have disposed of OA(EKM) No.2527/2017 with the observation that the remedy of the applicant is under sub-rule (8)(a) of Rule 28 b(i) of the KS&SSRs Part II without prejudice to the right of the applicant to avail the remedy.

3. The applicant submitted representation read as 2<sup>nd</sup> paper before the review DPC(H) requesting to reconsider his case and include him in the modified select list 2017 for the Executive Engineer in view of the finalisation of the disciplinary actions for minor penalty pending against him by barring one annual increment without cumulative effect for a period of one year and one annual increment without cumulative effect for a period of six months as per GO(Rt)No. 465/2018/LSGD dated 16.02.2018 and GO(RD)No. 424/2018/LSGD dtd 13.02.2018 respectively.

4. The review DPC(H) which convened on 27.02.2018 in pursuant to the above orders of the Hon' KAT considered the quantum of punishment awarded to the applicant and observed that he is eligible for promotion to Exe. Engineer only in the year of finalisation of the disciplinary action, ie 2018. Accordingly, the DPC has decided to include him as Sl no. '1a' just above Sri. Bijoy. K.N who is Sl no. 2 and Rank no. 33 in the select list 2018 for promotion to the post of Executive Engineer. Subsequently, the modified select list 2018 has been approved as per the recommendation of the DPC(H) and published vide GO read as 3<sup>rd</sup> paper above.

5. In the above circumstances, as the applicant is included in the modified select list 2018 for promotion to the post of Exe. Engineer by considering his review petition, the order of the Hon'ble KAT in OA(EKM) No.2527/2017 read as 1<sup>st</sup> paper above, has been complied with accordingly.
