ORDER

As per the letter read as 1st paper above, the Government of India sanctioned an amount of Rs.16.20 Crore as 1st installment of Central share under National Rurban Mission(NRuM) Phase III and it has been credited to the State Government Account. The Commissioner for Rural Development as per letter read as 2nd paper above has requested Government to accord sanction for releasing the aforesaid Central share along with corresponding State share of NRuM, Phase III and to transfer credit the amount to the Special TSB Account maintained by CRD at District Treasury, Thiruvananthapuram.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of Rs.16.20 Crore as 1st installment of Central share and Rs.10.80 Crore as corresponding State share under National Rurban Mission(NRuM) Phase III, as detailed below.
