**ORDER**

As per the sanction order read as 2nd paper above, the Ministry of Rural Development, GoI have sanctioned grant-in-aid amount of Rs. 12,54,49,000/- to State Government towards first instalment of Central Share under NRLM (General Component) during the year 2018-19. The Ministry has also sanctioned an amount of Rs. 10,27,60,000/-towards 1st installment of Central Share under NRLM (Scheduled Cast component) and an amount of Rs. 2,26,88,000/- under NRLM (Scheduled Tribe Component) during the year 2018-19 , as per the sanction orders read as 3rd & 2nd paper above respectively. The Executive Director, Kudumbasree vide letter read as 4th paper above has requested to issue sanction order for the release of the aforesaid Central Share amounting to Rs. 25,08,97,000/- ( Rs.12,54,49,000 + Rs.10,27,60,000 + Rs.2,26,88,000) along with the corresponding State Share of Rs. 16,72,64,667/-(Rs.8,36,32,667 +Rs. 6,85,06,667 + Rs.1,51,25,333).

2. After having examined the matter in detail, Government are pleased to accord sanction for the release of the the 1st installment of Central share amount of Rs. 25,08,97,000/- and its corresponding State share of Rs. 16,72,64,667/- for the implementation of NRLM/Ajeevika for the year 2018-19 as detailed below.
