ORDER

The Hon'ble Supreme Court as per the Order read above imposed costs of Rs.100000/- (One Lakh only) on the States/UTs, including State of Kerala, which have not complied with the orders passed by the Court on 27.03.2018 for preparing a policy in terms of Rule 11 and 15 of Solid Waste Management Rules 2016. The Costs be deposited within a period of two months from the date of judgment, with Supreme Court Legal Services Committee for utilization of juvenile justice issues.

As per the G.O. read above an additional expenditure to the tune of Rs.100000/- (One Lakh only) has been authorized under the **H/A 2217-80-001-99-34-3** in relaxation of economy orders in force, for remitting the fine imposed by Hon'ble Supreme Court for failure of State in framing a State Policy in terms Rule 11 and 15 of Solid Waste Management Rules 2016.

Government are pleased to accord sanction to release an amount of Rs.100000/- (One Lakh only) additionally authorized under the **H/A 2217-80-001-99-34-3** for remitting the fine imposed by Hon'ble Supreme Court in the Order SMW(C) No.1/20105 dated 10.07.2018 for failure of State in framing a State Policy in terms of Rule 11 and 15 of Solid Waste Management Rules, 2016. Director of Urban affairs is authorized to draw the amount and to deposit the same with the Supreme Court Legal Services Committee.

4. The Director of Urban Affairs shall take timely steps to regularize this additional expenditure through Supplementary Demand for Grants before the close of the current financial year.
