ORDER

Sri. Prasannabhas. E.R, Assistant Exe.Engineer has filed OA 350/2018 before the Hon'ble Kerala Administrative Tribunal aggrieved by non inclusion of his name in the select list for promotion to the post Executive Engineer by the DPC(H) for the years 2017 & 2018, due to the prevalence of disciplinary action for major penalty against him in connection with the irregularities in issuing building permit in Perumkadavila GP.

2. The Hon'ble Kerala Administrative Tribunal, vide Order read as 1st paper above, has directed the 2nd Respondent, ie the Convenor, DPC(H) to consider and pass appropriate orders on Annexure A5 representation, read as 2nd paper above, within a period of one month from the date of receipt of a copy of the order.

3. The request of the applicant in the Annexure A5 representation is to reconsider the above decision of the DPC and to include him in the modified select list 2017 for promotion to the post of Executive Engineer as he was due to retire from service on 31.07.2018.

4. The review DPC(H) 2018 which convened on 10.07.2018 in pursuant to the above orders of the Hon' KAT, after considering the case in detail has observed that the incumbent is not eligible for promotion to the post of Exe,Engineer as per note(i) below Rule 28(b)(i)(7) of KS&SSR 1958 as the disciplinary action for major penalty against him has not yet been finalised and the charges against him are still alive. Therefore the Committee decided not to include him in the modified select list 2017.

5. In the above circumstances, in view of the decision of the review DPC(H) 2018 the demand of the applicant in Annexure A5 representation deserves no merit and is hereby declined.

6. The Order of the Hon'ble KAT in OA 350/2018 read as 1st paper above is complied with accordingly.
