ORDER

Smt. Bijimole. E.R, Asst.Exe. Engineer has filed OA 432/2018 before the Hon'ble Kerala Administrative Tribunal aggrieved by non inclusion of her name in the select list for promotion to the post of Exe.Engineer by the DPC(H) 2018 which held on 14.12.2017, due to the pendency of disciplinary action for minor penalty against her in connection with the irregularities in Kulathupuzha GP as per the recommendation of the Vigilance and Anti-Corruption Bureau.

2. The Hon'ble Kerala Administrative Tribunal, vide order read as 1st paper above, have disposed of OA 432/2018 directing the 2nd respondent, ie the Convenor, DPC(H) to consider and pass appropriate orders on Annexure A6, read as 2nd paper above in accordance with law and after affording an opportunity of personal hearing to the applicant within a period of two months from the date of receipt of a copy of the order.

3. The request of the applicant in the Annexure A6 representation is to reconsider the above decision of the DPC and to include her in the modified select list 2018 for promotion to the post of Executive Engineer.

4. The review DPC(H) which convened on 10.07.2018 in pursuant to the above orders of the Hon' KAT has observed that the applicant is eligible for promotion to the cadre of Executive Engineer as above disciplinary action for minor penalty prevailed against the applicant was finalised by withholding one annual increment without cumulative effect for a period of one year vide GO(Rt)No.1820/2018/LSGD dated 03/07/2018. Therefore the review DPC(H) has decided to include her as Sl. No. 4(a) just below Smt. Sreelatha. P.R Sl. No.4 whose Rank No. is 55 in the modified select list 2018 for promotion to the post of Executive Engineer. Subsequently, the modified select list 2018 has been approved and published vide GO read as 3rd paper above.

5. In the above circumstances, the applicant has been included in the modified select list 2018 for promotion to the post of Executive Engineer after considering her review petition and accordingly the grievance of the applicant was redressed in full. The order of the Hon'ble KAT in OA 432/2018 read as follows paper above is complied with accordingly.
