**ORDER**

The Secretary, Kerala Public Service Commission as per letter read as 1<sup>st</sup> paper above has advised the following candidates for appointment to the post of Lecturer Grade I, Animal Husbandry (Direct Recruitment) in the Scale of Pay Rs.20,740 – 36,140 (pre -revised):

- 1) Smt. Sreeshma V.S. Vayalombram House, Kartikulam P.O., Wayanad– 670646.
- 2) Smt. Rincy M. Ali, Pulickal House, Sreemoolanagaram, Ernakulam – 683 580.

2. As per the letter read as 2<sup>nd</sup> paper above, the Commissioner for Rural Development has reported two vacancies in the post of Lecturer Grade I, Animal Husbandry (Direct Recruitment) in the KILA - Centre for Organic Farming & Waste Management, Thaliparamba (formerly ETC, Thaliparamba) and KILA - Centre for Socio-Economic Development, Kottarakkara (formerly ETC, Kottarakkara).

3. In the above circumstances, Government are pleased to appoint Smt. Sreeshma V.S., Vayalombaram House, Kartikulam P.O., Wayanad – 670646 and Smt. Rincy.M.Ali, Pulickal House, Sreemoolanagaram, Ernakulam – 683580 as Lecturer Grade I, Animal Husbandry (Direct Recruitment) in the KILA - Centre for Organic Farming & Waste Management, Thaliparamba (formerly ETC, Thaliparamba) and KILA - Centre for Socio-Economic Development, Kottarakkara (formerly ETC, Kottarakkara) respectively in the existing vacancy in the Scale of Pay Rs.29,200 – 62,400 on provisional basis under Rule 9 (a) (i) of the General Rules, KS & SSRs, 1958 as provided for in Rule 10 (b) of those rules. The advice of the candidates are subject to the Rule 3 (c) of the General Rules of the KS & SSRs 1958.

4. The Candidates are directed to report for duty before the Principals of KILA - Centre for Organic Farming & Waste Management, Thaliparamba and KILA - Centre for Socio-Economic Development, Kottarakkara respectively within 15 days from the date of receipt of the appointment order, failing which the appointment order will be cancelled and the Kerala Public Service Commission will be advised to cancel the advice without any further notice. The candidates should bring with them the original documents to prove Age, Educational qualifications and Original One Time Verification Certificate, failing which they will not be admitted to duty. They should also produce Medical Certificate [as prescribed in Rule 13, Part I, Kerala Service Rules and G.O. (P) 20/2011/P&ARD dated 30.06.2011] carrying thumb impression and passport size photograph signed by a Medical Officer not below the rank of a **Civil Surgeon**, three passport size photographs (duly attested on the reverse side) by a Gazetted Officer of State Government Service and AADHAR Card (UID Card) as stipulated in Circular No. 12521/AVC VI (3)/13/P&ARD dated 26.07.2013, so as to verify the identity. If they are not in possession of the AADHAR Card, Voter ID Card/ PAN CARD should be produced. If they are already employed in Government Service / Public Service Undertakings etc., they should produce necessary relieving orders, failing which the candidates will not be admitted to duty.

5. The candidates should produce Community / Non Creamy Layer Certificate in original for verification when they report for duty, if applicable.

6. The candidates are informed that in the event of discharge from service for want of vacancies, they may either re-register their name in the office of the Kerala Public Service Commission and get re-appointed on further advice from the Kerala Public Service Commission in which case they shall lost the right of probation to the post in the department from which they were discharged for want of vacancies or may wait for their turn for re-appointment to the post in the department in case they desire to continue as probationer in the post from which they were discharged.

7. The date of joining duty of the candidates should be reported to the Kerala Public Service Commission and to the Government immediately after the candidates joining duty. In case, the candidates does not join duty within the joining time allowed in the appointment order, the fact should be reported to the Kerala Public Service Commission as well as the Government immediately.


